BOARDER'S LEAVE POLICY

Rationale

As stated in the School Education Act 1999, it is expected that students attend school for each day that it is open for instruction.

23. Attendance

(1) A student must on the days on which the school is open for instruction —

(a) either —

(i) attend the school at which he or she is enrolled; or

(ii) otherwise participate in an educational programme of the school whether at the school or elsewhere, as required by the principal.

Definitions

- **Public Holiday** – is a day is gazetted by the government as a public holiday, and may occur at any stage in the calendared week.
- **Boarder's Long Weekend** – an additional Student Free Day, generally mid-term, which allows for boarding students to be able to travel home. Whenever possible, a Boarder's Long Weekend includes a public holiday with an additional Student Free Day. The College's Boarding facilities do not remain open during these times.
- **Gazetted Long Weekend** – when a public holiday falls on a day adjacent to a weekend (for example ANZAC Day occurring on a weekend), it creates a Gazetted Long Weekend. If this is in term time, it will generally be three days in length. If a gazetted long weekend is **not** incorporated into a Boarder's Long Weekend the College's Boarding facilities generally do remain open during these times.

Attendance Of Scheduled Classes

It is expected that all students (day and boarding) attend all contact days in the College's calendar. Boarding students are not permitted to be absent for additional days, whereby a Boarder's Long Weekend, Gazetted Long Weekend or a Public Holiday occur; as a

student's learning is directly affected by being absent from classes and often assessments are not able to be sat. In the interest of equity to all students who are in attendance; students who are absent and do not have a medical certificate, will be included under the College's Extended Leave Policy, whereby -

- Students will not be able to sit Assessments and Examinations earlier or later than the scheduled completion date. Students and their families are provided with an assessment outline at the commencement of the term/semester, so as to monitor deadlines. This is intended to ensure equity for those students who are present at the College.
- Where students are absent for a scheduled assessment or examination, a '0' will be awarded.
- It is the responsibility of students to ensure that they have maintained their study load whilst absent from regular classes. It is not the responsibility of staff members to provide additional 'catch up sessions' for students taking extended holidays.

Limited Exemptions

Whereby a student's travel arrangements are beyond their control (i.e. flights or trains only available on a particular day); and in consultation with the Head of Boarding and Deputy Principal, students may be rendered exempt from the above penalties.
